OJETTA ROGERIEE THOMPSON, J.D.

Doctor of Science in Criminal Justice Management

Circuit Judge Ojetta Rogeriee Thompson of the United States Court of Appeals for the First Circuit was nominated by President Barack Obama in October 2009 and confirmed unanimously by the Senate in March 2010.

An inspiration to minorities and women, Thompson is the first African-American judge and second female judge to serve on the First Circuit. She is a graduate of Brown University with a bachelor's degree in English, and received her Juris Doctorate from Boston University School of Law.

Thompson's professional career includes such esteemed positions as associate justice, Rhode Island Superior Court; associate judge, Rhode Island District Court; assistant city solicitor, Providence, R.I.; staff attorney, Rhode Island Legal Services; and nine years in private practice.

A dedicated member of the U.S. legal system, Thompson's professional affiliations include serving as a member of the National Bar Association, the Thurgood Marshall Law Society and the Rhode Island Women's Bar Association.

Thompson bestows much of her time and expertise upon her community by serving as a member of several boards and committees. She is a trustee emerita of the Brown University Activities Corporation, and a member of Brown University's Fund for the Education of the Children of Providence, Brown Leadership Council, and the Brown 250th Subcommittee on Community Engagement. She is also a member of the First Circuit Court of Appeals Judicial Council, trustee emerita of Bryant College, a member of the board of trustees of the YMCA of Greater Providence, and a member of Save The Bay's President's Leadership Council.

For her strong devotion to the justice system, the community and to women universally, Thompson has been lauded with several accolades, including the 2013 Trailblazer Award by the Massachusetts Black Lawyers Association and the 2011 Boston University School of Law BLSA Annual Lifetime Achievement Award. In 2010 she was inducted into The Rev. Dr. Martin Luther King Jr. Hall of Fame of Providence, and was the recipient of The Community Service Salute from the National Coalition of 100 Black Women, among numerous other honors throughout her career.

Originally from Anderson, S.C., Thompson and her husband, The Honorable William C. Clifton Sr., live in Cranston, R.I. and have three children.
