Visitor Policy Reminders

For the complete Visitor Policy and all other policies with which all guests or visitors must abide during their visit, please refer to the Student Handbook, the Guide to On-Campus Living, and Student Host's Housing Contract.

- No guests under the age of 16 are allowed in university housing, even with the permission of a parent or legal guardian, unless the parent or legal guardian is with them at all times. Under no circumstances may anyone under 16 years of age stay overnight in any university Housing, even if accompanied by a parent or legal guardian.

- For guests who are 16 or 17 years old, both the guest and a parent or legal guardian must sign the Visitor Agreement.

- All guests may be required to present valid picture identification (ID) to be granted access to university Housing. This should be a state issued ID that provides a picture and date of birth; high school IDs or other college IDs will not be accepted.

- Violations of university policies by guests could result in disciplinary action against the Student Host, up to and including loss of guest privileges, suspension, or expulsion. In its sole discretion, the university may contact the guest's emergency contact.
